## FIRE PROTECTION ORGANIZATION AND RESPONSIBILITIES

1. Mr Iztok BRICL the General Manager of Gospodarsko Razstavišče d.o.o., is responsible for the organization of fire prevention measures. MIKROTOP d.o.o. Ljubljana, Koprška 98, Ljubljana, tel.: 01 244-62-35 is responsible for the implementation of fire protection.
2. Hall E is intended for fair and exhibition activities. In the basement area there is a shop and the restaurant (with kitchen) and store. In ground floor Hall E may be located up to 50 people.

## FIRE PREVENTION MEASURES



**FIRE EXTINGUISHER**

3. Devices, equipment and instruments needed for fire prevention must be placed in hall and on exhibition sites. Devices, equipment and instruments must only be used for intended purposes only and must be checked and maintained on a regular basis in compliance with regulations and technical directions of manufacturers.
4. Smoking and use of open fire is strictly prohibited. Person, responsible for the fire protection must be notified if the open fire is needed for a certain job. In this case, written permission must be issued and fire watch must be organized.
5. The corridors, staircases and exits from facilities which also serve as evacuation routes must be appropriately marked, always clear and accessible. Access to equipment and other resources for fire protection should always be free and accessible.

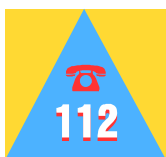


**ESCAPE**

6. Everybody in exhibitions hall must follow regulations for working in the exhibition halls on the Gospodarsko Razstavišče.

## INSTRUCTIONS IN CASE OF FIRE

7. Everybody in the exhibition hall must follow the instructions provided by employees, guards and fire wardens.
8. Everybody who is located in the exhibition hall must immediately report any irregularity, which endangers the health, life or property to the nearest employee and other companies involved.
9. In case there is an imminent risk of fire or explosion or if a fire is noticed, you shall:
  - remove threat or extinguish the fire if this can be done without danger to yourself and others present,
  - Shout '**FIRE**' and trigger the fire alarm, if there is no chance to put out fire
  - Leave halls without panic, follow instruction for evacuation and gather on a meeting point,
  - follow the instructions of the Head of the intervention, which organizes and supervises fire fighting and under his instructions help the injured and wounded and participate in extinguishing the fire.
